

Shir Tikvah Waiver - Effective May 2021

Thank you for being part of the Shir Tikvah community! We look forward to welcoming you to the building in a manner that is informed by public health guidance and protects members of our community.

Effective May 2021: Consistent with public health recommendations, we require that everyone follow our rules regardless of vaccination status, prior infection, or recent negative test result.

Face mask must be properly worn inside the building. This means covering the mouth and nose area with support straps around the ears or head. A mask will be provided if you do not have one. No one will be allowed to enter the building without a properly worn face mask.

Practice social distancing when in the building. Maintain at least six feet distance between people not living in the same household.

Please use hand sanitizer stationed in the building as needed.

Sanctuary use for hybrid in person/Zoom services. Maximum capacity 25 members

Services will be held in the building on Friday evening and Saturday morning. Saturday morning services will alternate weekly between Conservative and Reform formats.

A Board member will attend each service to ensure all the rules are being followed. Your health and safety are our main concern. Anyone not observing the rules will be asked to leave the building.

All members should be registered for the service with the Shir Tikvah office at least two days in advance. You can register by contacting Diedre at the office or online with Signup.com. Signup.com will be used to track service attendance.

Prior to registering, all attendees must self-screen themselves by completing the COVID-19 Screening Questionnaire. If you answer YES to any of the questions you will not be allowed to register for the service. On the day of the event, please screen yourself for symptoms again. If you answer yes to any screening questions, please stay home to protect others.

Upon arrival, do not congregate by the entrance, foyer, or hallway. After entry, individuals should proceed immediately to seats to avoid congregating. Only sit with people within your household and six feet away from others.

No handshaking, hugging or kissing when greeting others.

No Choir until further notice. No food service will be allowed in the building.

Only one person is allowed in the restroom at a time. If a line forms near the restroom, please remain six feet from each other in the main hallway.

Bring your own kippah and tallit when attending services. No shared ones will be available. We will use the existing prayer books.

By attending in-person events at the synagogue, you acknowledge the following:

1. You agree to abide by the rules of the synagogue.
2. You understand and agree that even with these precautions, Shir Tikvah cannot guarantee your safety considering the pandemic. You must exercise your own sound judgment and good discretion to determine whether it is safe for you to attend in person, in the building.
3. Shir Tikvah is not liable, and assumes no responsibility, for COVID related sickness or injury incident to, or resulting from, the pandemic, the foregoing rules, or any violations of the foregoing guidelines.
