Rabbi's Message

given at the Shir Tikvah Annual General Meeting, June 20, 2021

It's hard to believe the year that we've had. It was one of the most challenging and yet also one of the most rewarding years in recent memory. As a community, we were forced to think outside the box and to reimagine our usual services and programs. And I think that

we truly succeeded.

At the high holidays, we rang in the New Year 5781 on Zoom. And though we could only gather virtually, our spirits were nonetheless lifted as we shared in old traditions and began some new ones. I celebrated Rosh HaShanah and Yom Kippur with our Conservative minyan last fall, and then planned and led services for Sukkot, Sh'mini Atzeret and Simchat Torah for the entire Shir Tikvah community.

At the same time, I partnered with our wonderful school coordinator, Barb Cohan, and our terrific teachers, Carole Fefferman and Sherry Dieckman, bringing our (masked) students to the sukkah and having a chance to shake the lulav and etrog in spite of the pandemic. Throughout the year, I had many such opportunities for collaboration with our school staff; whether through weekly planning meetings, student participation in services, or virtual field trips, we did our best to provide the best learning

environment possible in a year that was almost completely online. Donelle Macey helped to make some Sundays especially fun, guiding us through the baking of bagels and Chanukah cookies. Despite a few hiccups along the way, it was a pleasure to interact with our kids and to work with all of our teachers. We look forward to another great year ahead, God-willing, in person.

In addition to Sukkot and Simchat Torah, I led services on Zoom this year. It was far from ideal, but as time passed, we slowly but surely figured it out. We went from a few songs and readings to a full service, from my dining room table to the



sanctuary at Shir Tikvah. We

welcomed members from right here in the south suburbs to friends, old and new, from across the country. I led Kabbalat Shabbat, Shabbat morning and festival services. I took part in another outstanding community Seder, and I led megillah reading for Purim. But perhaps some of the most meaningful services came in the form of three b'nai mitzvah last summer and fall for Grant Goldberg, D.J. Munson, and Chuko Akujieze. I worked with each of these young people each week as we studied their Maftir, Haftarah, and worked on their D'var Torah. And each, I truly believe, brought his unique perspective to the lessons he taught us

from the parasha. I have begun to study with our next bat mitzvah, Grace Goldberg, and look forward to working with Rachel Latman, Chase Levy, and Josh Bloomberg in the near future as well.

A huge thanks goes out to our sisterhood, the Women of Shir Tikvah, who continue to do extraordinary things in our community! And a tremendous amount of gratitude to our fundraising, adult education, ritual, school, house, and reopening committees, who helped ensure that our building and our



people remained strong and vibrant even in this toughest of years! Thank you, thank you to our board for making tough decisions and supporting Shir Tikvah throughout this pandemic and beyond!!!

Though the pandemic made it impossible for me to visit with people in person, I made many phone calls and did my best to connect with people over Zoom as well. I know that isolation was a tremendous issue in the last year. I am so grateful that over the past month or two, as people have gotten vaccinated, we've been able to reunite - in 3D! President's Message, delivered at our Annual Meeting



Welcome to the third Annual Meeting of Shir Tikvah. This has been a year like no other. When I accepted the position of President-Elect two years ago, I had concerns about taking on this role, but nothing prepared me for dealing with a pandemic.

This has been a difficult year for all of us, but we pulled together to maintain Shir Tikvah as a source of community. We learned new ways to communicate and how to be together via Zoom. As we meet today, we begin the process of returning to normal and becoming stronger as a congregation.

As a congregation, we heard about members who were feeling isolated and other members who were not able to get out of their homes. As a result, the board created a Caring Committee to reach out to provide a personal connection with members of the congregation. Thank you to Eila Koltun for volunteering to chair the committee. The committee members started by calling on our most senior members and those on the Mi Shebeirach list or those with family on the list. The feedback we received was positive, and this committees work will continue. If you would like to receive a call or join the committee to make social calls to other members, please contact Eila or the office.

We purchased Notebird software to keep track of the calls, and the software has improved communication between me, Rabbi Harari, Diedre and Eila. We are updated when information is entered pertaining to a member. We are using Notebird to maintain the Mi Shebeirach list, birthday and anniversary list, and general membership information. This will ensure we are in touch with members in their

time of need.

Over the last year, the Adult Education Committee has provided various forms of content to our members via Zoom to keep everyone engaged. Barry Sturm has been Chair of the committee since 2014 and has done an excellent job. Barry and his committee look for programs of interest, schedule the events, and complete detailed forms to receive JUF mini grants to cover the cost. I found the speakers to be highly qualified and the topics to be engaging.

Although we could not meet in person, we continued to provide tzedakah to the community. Working with Amy Bloomberg, Shir Tikvah donated the use of our parking lot as a collection site for three JUF TOV Volunteer Network events. These events collected necessities for service organizations and provided limited social interaction during the lockdown. Amy, our JUF representative, has been a great resource providing services to our community, including a training session for the Caring Committee.

Our facility has become the center of activity for Jewish events in the South Suburbs. Shir Tikvah will host Shalom over 50 when it re-starts in person at the end of June and the Cooperative Jewish Council (CJC) Sabbath on July 9. In July, the National Council of Jewish Woman (NCJW) will be packing their Honey for the Holidays in the social hall. The Maxwell Street Klezmer Band will perform August 8 as part of a JUF mini grant. We are planning on resuming yoga classes later this summer. It is great to see our facility being utilized for so many activities.

For as long as I can remember, Gary Schwarz has kept our facilities in great shape. Gary works closely with Bob, our Jack-of-all-trades maintenance person, to maintain the day-to-day operations of the property. Although the building was rarely used during the last year, it still needed to be maintained. This year the HVAC unit for the main sanctuary needed to be replaced. This was a major capital project costing \$23,000. The contractor noted the old unit lasted 20 years past its normal useful life. That is an example of Gary and Bob's devotion to keeping our facility well maintained over the years.

A financial opportunity arose when our neighbors asked to buy the unused property behind our parking lot. The neighbors on Olive Road wanted to extend their back yards and purchase a section of the unused field. Dan Greenberg oversaw this project, and after negotiations, the sale is scheduled to close this month. Dan has done an excellent job negotiating with the two buyers and working on the legal aspects of dividing and selling the lots. When Dan agreed to function as our legal counsel, I doubt he was expecting this much work. Many thanks to Dan for donating his time and expertise to get this transaction completed.

For the first time in 15 years, I will not present a Treasurer's report. Irwin Friedman agreed to take on the treasurer's position and has done great job monitoring our financial position. In addition to his treasurer's duties, Irwin procured a FEMA grant which provided funds to add protective coatings to our windows, additional security cameras, and reimbursement for armed security guards.

Irwin, working with Diedre, kept the office running throughout the pandemic. When the office was closed, Diedre came in to pay bills and make deposits. Diedre is a great asset to the congregation. In addition to the accounting, she manages the Yahrzeit program and the new Notebird program. Her most valuable attribute is being a resource for our members who need assistance.



Preparing the budget for the prior year was a difficult task. With the pandemic affecting us all, there were

concerns how these changes would affect donations. We decided to budget the dues and Kol Nidre according to our long-term plan. The financial support of our members was fantastic. Thank you to everyone. Your support through dues and Kol Nidre contributions is a sign of your faith in Shir Tikvah.

Ruth Friedman and her fundraising committee did a fantastic job and exceeded expectations. Since we would not be able to host in person events, we expected fundraising to be lower. Thanks to the creativity of Ruth and her committee, this was a successful fundraising year. The Ad Book came in just under last year, due to the continued support from our members. Shalach Manot set a sales record, and there were new activities which we will continue in the future: Aurelio's night and holiday food sales.

The school completed its second year with COVID restrictions. Barb Cohan, the school administrator, kept the focus on the children and maintained open lines of communication with the parents. We give a special thank you to our



teachers: Carole Fefferman for Hebrew school;

and Sherry Dieckman and Rabbi Harari for Sunday School. My daughter is a teacher and I have heard how difficult it is to keep children's attention on Zoom for hours of school. This year our teachers needed to be extra creative to keep the students focus after school and on Sunday. Thank you to our parents for their support and feedback.

Ritual observance is the main priority of our synagogue and was especially important during the trying times we were living through. The Ritual chairs, Carole Fefferman and Janet Herbstman, did an exceptional job ensuring that services continued throughout these challenging times. High Holiday planning and execution became a new experience as we planned two virtual services. I will admit, monitoring the Reform services was my most stressful time as President. The High Holidays were a success and provided us all with a spiritual renewal. We now look forward to returning to the synagogue for services, along with plans for outside services.

Rabbi Harari had to adapt to the changing environment, conducting services first from her home and then from an empty synagogue. I know this was a difficult year for her. I saw her joy when we held our first in person trial service and she heard us singing with her. Rabbi Harari has kept busy on the phone and Zoom, staying in contact with our members in need and attending committee meetings. We made an exception last summer to allow three B'nai Mitzvahs to be held in the synagogue with limited attendance. We were all masked and distanced, and the services were beautiful.

We all know how active Gayle Weil and the Women of Shir Tikvah are and how the lack of social contact with members was difficult. Gayle seems to be involved in everything, and she became a reliable contact for me to call. The

Women of Shir Tikvah contribute at every Shir Tikvah function. A Passover Seder was held on Zoom which provided a nice sense of community.

This was a year when many difficult decisions needed to be made. I want to thank the Board of Directors for the meaningful discussions and debates around these tough decisions. The Re-Opening Committee did a great job providing information to the Board, which then debated the issues. Several times, reopening was considered, but then the pandemic would surge again. It was frustrating to keep the synagogue closed, but it was in the best interest for the health of our members and staff.

Thank you to Sherry Dieckman and Sherman Friedman for being a sounding board for me and pointing me in the right direction when I was looking for guidance. Together they also oversaw the virtual High Holiday preparations.

This will be a year to remember as we begin to see the light at the end of the tunnel. As we welcome congregants into the synagogue, we will continue to provide the services on Zoom. Zoom has allowed Judy Lohr-Safcik to stay active from Arizona and Rabbi Harari's father to join services from Florida. We will take the lessons learned from this year and integrate them with our normal operations going forward. This year Shir Tikvah did an amazing job of adapting to the situation we found ourselves in. We worked together to keep the congregation viable until a time when we could be together in person. This is the spirit of Shir Tikvah, and I am proud to have been the President as we pulled together as a congregation, and I look forward to the new year.



We are thrilled to join with dozens of congregations throughout the Chicagoland area for a virtual (Zoom) session: Hinei Mah Tov: Israeli and American Jews' Views of Each Other. And how liberal Jewish movements in Israel have made progress, faced opposition, and cooperated with Rabbi Naamah Kelman and Professor Elan Ezrachi.





Dr. Ezrachi and Rabbi Kelman will reflect on their shared life journeys, from the viewpoints of an Israeli and an American who met 45 years ago. They will talk about what Israel and American Jewry were like when they met, and how they saw the other in this context. They will also discuss how things have changed over the decades that they have been together, and their respective roles and activities. Additionally, Dr. Ezrachi and Rabbi Kelman will describe the progress made by both Conservative and Reform Judaism in Israel, as well as collaboration between the two movements on issues of mutual concern, including with unconventional Orthodox leaders and institutions.

Two breakout sessions will follow: Rabbi Kelman will discuss the renaissance and challenges of Jewish life in Israel through her work as a rabbi and the Dean of Hebrew Union College in Jerusalem. Professor Ezrachi will focus on issues of Jewish peoplehood, Israel-Diaspora relations, and his work teaching Israelis about American Jewry.

There are two opportunities to attend! Both sessions will be live, contain the same presentation, and provide the opportunity for Q&A. We encourage you to take part in what promises to be an intriguing look at the relationship between American and Israeli Jewish communities.

Rabbi Naamah Kelman is a descendant of 10 generations of rabbis, becoming the first woman to be ordained by the Hebrew Union College in Jerusalem in 1992, where she is currently the Dean. Born and raised in

New York, she has lived in Israel since 1976; where she has worked in

community organizing, Jewish education, and the promotion and establishment of Progressive and Pluralistic Judaism for Israelis. Naamah Kelman has been intensely involved in the emerging education system of the Israeli Movement for Progressive (Reform) Judaism. Among the founders of the first Progressive day school, she has overseen the development of curricular materials, teacher training programs, and family education. She has been engaged in teacher training and enrichment, the professional development of Israeli Rabbinical students, and the establishment of "Mazorim" Spiritual Care/Israeli Chaplaincy. She was the Director of the Year in Israel Program for HUC's North American students. She is a board member of Rabbis for Human Rights, MELITZ, and the Tali Education Fund. Naamah Kelman is deeply engaged in inter-faith dialogue and feminist causes. She is married to Dr. Elan Ezrachi and they have three children.

Elan Ezrachi, PhD, is a Jerusalem-based consultant in the areas of Jewish Peoplehood education and Israel engagement and the author of Awakened Dream – 50 Years of Complex Unification of Jerusalem.

He was born in Jerusalem where he also resides. After six years as a helicopter pilot in Israel's Air Force, Elan went on to pursue a career in Jewish education. He has served in various executive roles including: the International Dept. of Melitz – Center for Jewish Zionist education, the Charles Bronfman Mifgashim Center, Masa – Israel Journey (founding CEO), and the International School for Jerusalem Studies at Yad Ben-Zvi.

Elan received his BA and MA from Hebrew University in Education and Jewish Thought and a doctorate from the Jewish Theological Seminary in New York. His dissertation topic was: "The Dynamics of interaction between American Jews and Israelis". Along with his executive career, Elan has taught at the Hadassah Academic College, the Schechter Institute, and Hebrew Union College in Jerusalem. He currently teaches at the University of Haifa at the MA Ruderman Program on American Jewry and the MA program on Jewish Peoplehood.

Elan is married to Rabbi Naamah Kelman and is a grandfather to five boys.
